<u>SELECT BOARD / TOWN MANAGER</u>- Tax bills will be sent out late August or early September. If you do not receive a bill by September 15th, please call the town office. First half of the payment is due October 31, 2023 and second half is due March 31, 2024. Remember you can make weekly or monthly payments as well ~ anytime any amount.

We are thrilled by the grant received by the Stephen and Tabitha King Foundation. The grant for \$30,000 will be used to purchase and update our worn fire equipment.

There will be a couple of changes to trash and transfer station disposals. Tires will not be accepted in curbside trash and dumping brush at the transfer station will require a punch to your card. Both will be effective September 1, 2023.

LD290 "PROPERTY TAX STABILIZATION FOR SENIOR CITIZENS- program enacted in August 2022 has been repealed by the Maine State Legislature on July 6, 2023 with an effective date of October 11, 2023. The program had allowed Maine seniors 65 years and older who owned a permanent Maine residence for at least 10 years (and who were receiving a Homestead exemption) to "freeze" real estate taxes at the previous year's level regardless of income. The repeal of the program means **there will be no reapplication process and no need to follow up with the Assessing Office of your town**. Although the program has been repealed, any qualifying senior's application for the 2023 tax year will be honored and they should receive a tax bill with the "frozen" property tax bill from the 2022 tax year.

RSU 24- Summer work has started in each one of our buildings. Maintenance and upkeep are the focus this summer. Among the projects in the district are window replacements and a new gym roof at Cave Hill, new flooring and window replacements at Mountain View, new roof on the Ella Lewis portable building, roof repair at the Peninsula School, asphalt work at Mountain View and Ella Lewis and a major upgrade of the HVAC system at Mountain View. Fortunately, we had money set aside in a reserve that will cover a good portion of the work being done. We do have a number of vacant positions in the district! If you are interested or you know someone who is interested in a teaching job, an educational technician job, or a custodial or maintenance position, please contact Chris Alvarado from Human Resources at <u>calvarado@rsu24.org</u>. Of note, we are in desperate need of bus drivers. We do not have drivers for two routes which will create issues for us if we have to start the school year with this shortage. Anyone with questions or who might be interested in driving a bus for the district is encouraged to contact Janet Jordan (Facilities and Transportation Director) at jjordan@rsu24.org. The finish line is in view in regards to the new building project. The Certificate of Completion is being reviewed so that all parties can sign off on the building. We are still in the planning phase for the domestic water cistern project, have a punch list that the general contractor continues to work on, and our athletic fields continue to be developed. Our expectation is that we will begin the next school year under a far more "normal" situation at the new building. For those planning ahead, school for our students in grades PK-9 will start on Tuesday, August 29th. Grades 10, 11, and our seniors will return on August 30th! More information about next year will be distributed from each of our schools as we get into August. For those moving into the area or those still needing to register students, please contact your local school to check the summer hours in order to complete the registration.
