## Specifications

Provide traffic control

Grind all leading and following edges

Asphalt driveways will have a ground and tapered apron 12" in depth

Dirt driveways will have 12" in depth apron

Sweep roadway prior to HMA placement

Install hot bituminous asphalt 19mm shim/cap

The overlay will be rolled to an average of one and three quarters (1<sup>3</sup>/<sub>4</sub>) inches

All work will be in compliance with the most recent MDOT Supplemental Specifications, Section 401.10

## Work Area

Old Route 1- ~.5 mile from Route 1 back to Route 1- 2830' +-

Bartlett Hill Rd.- ~.2 mile from intersection of Old Route 1, to end of pavement- 1020' +-

Ashville Rd.- ~.3 mile from Route 1 to Sullivan town line (flagged)- 1605 +-
